

MISSION STATEMENT:

The Indigenous Affairs Office plans and executes **programs** aimed to **promote, practice, preserve,** and **perpetuate** the **Chamorro Language and Culture of the Northern Mariana Islands.**

OBJECTIVES:

The Indigenous Affairs Office (IAO)

Established in June 1985 during the 2nd Constitutional Convention, Article III, Section 23 of the CNMI Constitution designates the Resident Executive with the following roles and responsibilities:

- Coordinate the development, distribution, adoption, and translation of a comprehensive history of the Marianas.
- Ensure local participation in executive managerial decision-making within both government and private sectors.
- Assist and promote the growth of local entrepreneurship.
- Establish a community foundation dedicated to advancing the rights and welfare of indigenous people.
- Coordinate the translation and dissemination of key documents, including the Constitution of the Commonwealth of the Northern Mariana Islands and the Covenant, along with their analyses.
- Plan for the creation of the Indigenous Cultural Center and the Indigenous Hall of Fame.
- Coordinate an annual cultural festival to celebrate local heritage.
- Develop and implement a long-term strategy to support the entry of indigenous individuals into professional and technical higher education institutions.
- Serve as an advocate for the positions and concerns of indigenous people on various issues presented to them.

VISION:

To **protect** the **Chamorro language** and our **cultural heritage**, we aim to **enable our children, visitors, and community members** to **speak and engage** with our traditions.

Challenges:

- **Funding Limitations**
 - Projects are on hold due to inadequate funding. Awaiting approval of IAIO Proposals.
 - Ancient Burial Sites
 - Lost Souls
 - Hall of Fame for our Indigenous Chamorro and Carolinian Peoples
- **Office Completion Pending**
 - Pending expansion of the Medicinal Garden at the Main Office
- **Staffing Concerns**
 - There is a lack of personnel available to carry out community projects.
 - Partnership with DCCA Arts Council, HPO, DOA, OYA, DYS, NMI Museum, CAO, WAO, JKPL, and other non-profits with IAIO Projects
 - Requesting FTE for the island of Tinian and Rota
 - Building partnerships among agencies to fulfill duties and responsibilities
 - maintenance of latte sites with DOC





- The Indigenous Affairs Office is made up of four staff members: a Resident Executive, a Program Manager, an IAO Representative, and a Cultural Outreach Specialist.
- To enhance outreach efforts, the Indigenous Affairs Office engages Seasonal Cultural Practitioners to present our traditional Chamorro knowledge at community events and Indigenous Affairs Projects.
- SLL 24-02 has allocated \$25,000.00 to assist the Department of Agriculture in organizing the 38th Saipan Agricultural Fair. However, due to unfavorable weather conditions, the event has been postponed until May 2026. The funds have been successfully transferred and deposited into SAFA, a non-profit organization that supports the DOA in its annual Agricultural Celebration. Additionally, \$10,000.00 was transferred from Grants and Management, as approved by the late Governor, Arnold I. Palacios.
